Since 1997, the Valero Texas Open has helped hundreds of local non-profit charities and schools raise money through a grass-roots fundraiser, Birdies for Charity®; a no-cost program that gives 100% of the funds raised back to participating organizations.

Birdies for Charity is like a walk-a-thon but instead of donating per mile, donors make a pledge for every birdie made during Valero Texas Open tournament week. Last year there were 1,834 birdies made, so a \$0.01 pledge yielded a donation of \$18.34.

This unique and engaging platform also provides the option to make a one-time contribution in lieu of a pledge. All contributions and pledges can be paid in advance or be billed after the tournament. International donations are welcome and all donations are 100% tax deductible.
