

## Guess the Champion Contest Contest Rules

- 1. Void where prohibited by law.
- 2. Need not be present to win.
- 3. Donor must provide his/her name and email to become eligible to win.
- 4. Winners must be eighteen (18) years as of November 5, 2020 to be eligible to win the grand prize.
- 5. Participating donors who have provided an email address will receive an email from tournament officials after the PGA TOUR player field is announced on Friday, March 26, 2021.
- 6. Donors will have until Wednesday, March 31, 2021 to select from the player field who they believe will win the tournament.
- 7. The winner will be drawn from those who correctly guessed the tournament champion and receive the grand prize, along with earning the benefiting charity a donation of \$5,000.
- 8. Only one (1) Grand Prize will be awarded. The Grand Prize will be given to the person who exactly guesses the Valero Texas Open champion during the defined measurement period.
